The applicant may apply for a Refund by completing this Refund Application and attaching supporting documents to prove that:

- Visa/Study Permit application has been declined/cancelled; or
- Application for admission to a Canadian Educational Institution has been declined; or
- The applicant has withdrawn admission from the Canadian Educational Institution.

Note: Upon receipt of proof of any of these events and confirmation from the Canadian visa office, India, ICICI Bank Canada will redeem the outstanding amount. However, all processing and administration fees will not be refunded.

Instructions for Completing this Application Form:

1. This is a fillable PDF form, kindly complete all the fields in a **TYPED** format.
2. Ensure that all the information provided is correct.
3. Fill the complete form and press Validate button given at the end of the form.
4. Print, Sign and Date this form.
5. The following supporting documents need to be submitted while applying:
 - Refusal Letter (all pages) provided by Canadian Visa Authorities in India; or
 - Passport page showing the cancelled Visa/Study Permit by the Canadian visa office, India; or
 - A letter duly signed by the applicant confirming that the applicant has not applied for the Visa/Study Permit
